



NLRB Election Statistics Year-End 2022 Report Highlights

The number of resolved representation elections held by the National Labor Relations Board increased to 1,573 in 2022 from 1,021 in 2021, according to preliminary data analyzed by Bloomberg Law. Unions won 1,196 of these elections in 2022, an increase from 764 wins in 2021.




Unions prevailed in 76% of representation elections in 2022. The win rate rose above 70% for the fifth time in the last five years. Unions have won more than 60% of all representation elections in each of the past 18 years.

The number of workers eligible to vote in representation elections increased to about 95,000 in 2022 from about 51,000 in 2021. The number of workers organized by unions rose to 75,000 in 2022, up from 37,000 in 2021. The number of workers organized in 2022 was the highest since 2013.



There were 155 resolved decertification elections in 2022, up from 151 in 2021. Unions prevailed in 56, or 36.1%, of these elections in 2022, compared with 55 or 36.4% of decertification elections in 2021.

AFL-CIO unions won 73% of their 2022 representation elections, compared with 72.6% the previous year. Unions in the Change to Win coalition won 77% of their representation elections in 2022, versus 69.8% in 2021. The win rate for independent unions decreased to 78.1% in 2022 from 83.8% in 2021.

The Service Employees International Union (SEIU) led all unions with 471 representation elections in 2022, winning 386 or 82%. The Teamsters were the second most active union in 2022, with 219 elections, winning 145 or 66.2%. The Teamsters organized approximately 4,950 workers in 2022, while SEIU organized about 19,900.


A breakdown of 2022 representation elections by bargaining unit size shows that the highest union success rate was among the largest units and the second-highest rate was among the smallest units. Unions won 76.6% of elections involving bargaining units of 1-49 workers. Unions won 74.8% of elections involving 50-99 workers, 70.8% of elections involving 100-499 workers and 87% of elections with 500 or more workers. The 23 representation elections with 500 or more workers was the most since 2011. In 2022, 79.3% of representation elections held involved 1-49 workers.

Of the 1,573 representation elections held in 2022, 368 took place in states that have right-to-work laws in place. Unions won 73.1% of these elections. In non-RTW states, unions won 77% of 1,195 representation elections held in 2022.



Notes About the Data

Bloomberg Law maintains a database of union elections based on information from the NLRB and its regional offices. Statistics are calculated on a calendar-year basis. Data are available from January 1, 1988.

Bloomberg Law collects election tallies and certifications from the 26 regional offices of the National Labor Relations Board. This data is merged with certified election results reported by the NLRB national office in its monthly "Cases Closed" report.

Bloomberg Law statistics are based on resolved NLRB elections where an outcome has been declared at the regional level, based on a tally of ballots, or at the national level, through the certification of election results. The number of resolved NLRB elections can change over time due to a variety of reasons, including the resolution of challenges and objections, the cancellation of elections, and re-run elections. All historical statistics presented in this report have been revised from previous reports.

At the time that the data for this report was compiled, of the 6,699 representation and decertification elections records reported between January 2018 and December 2022, approximately 134 were still classified by the NLRB as "open." The vast majority of these will be closed normally over the next few months. This report's totals do not include 25 elections that are classified by the NLRB as "challenges determinative."

Future editions of this report will include slight changes to its totals and percentages to account for the resolution of records in both of these groups.
